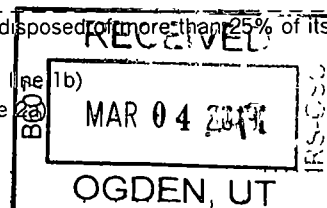

The Pan Florida Challenge (PFC) funded over 1.1 million meals to feed hungry children in south Florida, during the 2017-2018 school year. The PFC received \$619,330 in contributions and grants and had \$803,231 expenses in fiscal year 2017. The PFC Power Packs (trademarked) are child friendly meals that meet or exceed the USDA recommendations for calories, carbohydrates, and protein. The PFC purchased \$495,419 in meals in 2017 and made grants for food totaling \$19,000.
