A MIXTURE OF 59 ADULTS AND CHILDREN PARTICIPATED IN THE RESPITE PROGRAM. THE HOURS ARE BEFORE AND AFTER PROGRAMMING, WHICH EQUATES TO 7:00 AM TO 9:00 AM AND FROM 3:00 PM TO 6:00 PM. THIS YEAR ROUND SERVICE ALLOWS PARENTS TO WORK AND PICK UP THEIR SONS/DAUGHTERS AT A CONVENIENT TIME. THIS IS A SAFE AND INTERACTIVE CARE PROGRAM THAT BENEFITS MORE THAN JUST THE FAMILY.
