Tours & Retreats: Our youth choir went on tour to the Golden Gate Festival and won a number of awards. It was a very successful tour. Our women's choir went to New York for an exchange with another women's choir that they then hosted in Seattle. Retreats enable bonding and emotional preparation for longer tours, & provide an opportunity to get a jump on music early in the season.

4b (Code) (Expenses \$ **88,688.** including grants of \$ **2,246.**) (Revenue \$ **133,908.**)

Rehearsals: Rehearsals are the primary focus of the organization, providing music instruction to singers aged four through adult. Rehearsals allow our members to improve and hone their skills to become better musicians and singers, as well as to learn music in preparation for concerts, performances on tour, community outreach concerts, and other musical events in which we participate. Rehearsals teach the singers basic music skills, how to read music, music theory and sight-reading, and help the singers improve vocally as an individual, as well as a choir member.

Concerts: Performances help singers work toward goals, become more comfortable on stage, learn pre-performance routines and contribute their art to worthy causes while providing the community with free or inexpensive opportunities to enjoy music.
