People in Board discuss the seminary students' situation, the need for the scholarship, the potential of the student in terms of being a Christian leader, and other activities the student is involved to determine whether a scholarship and mission fund should be granted. The student that we supported does not have any job, and is actively supporting the fellowship, especially the fellowship in University of Berkeley. The student is a Doctorate at Trinity International University - Trinity Evangelical Divinity School.

Regarding grants to campus fellowship activities, only the actual expenses for food and activities related expenses will be reimbursed and recorded as an expense. In addition, fellowships in campuses also invite Christian speakers to give speeches which mainly target non-believers. Some speakers we invited are full-time preachers. The average price to full-time preachers is \$200/ speech. No other expenses would be approved nor reimbursed.
