SUMMARY OF PROGRAM RELATED INVESTMENTS.

ALL OTHER PROGRAM RELATED INVESTMENTS

- (1) The Foundation leases a building located in Kannapolis, North Carolina for the purpose of housing the North Carolina Music Hall of Fame. Improvements were made to the leased property and the space has been made available for the general public to visit presently at no charge in furtherance of the Foundation's charitable and educational purposes.
- (2) The Foundation owns the Sony Building at 34 Music Square East, Nashville, TN. The building is currently being used by Belmont University, Leadership Music, and The Nashville Songwriters Foundation, Inc., in furtherance of the Foundation's charitable and educational purposes.
- (3) The Foundation owns the building located at 1034 Audobon Drive, Memphis, TN, known as the "Elvis Presley House". The building has been used periodically at no rent, by Rhodes College of Memphis, Tennessee for the college's programs in the furtherance of the Foundation's charitable and educational purposes.
- (4) The Foundation purchased the Buddy Lee Building at 38 Music Square East, Nashville, TN, fiscal year ended July 30, 2016. The building is currently being used by various music and entertainment entities that reimburse the Foundation for current operating expenses, an arrangement in furtherance of the Foundation's charitable and educational purposes.
