THE WOMEN'S ECONOMIC SECURITY INITIATIVE (WESI). WESI IS A SYSTEMS-LEVEL COLLABORTIVE INITIATIVE CENTERED AROUND THE SHARED VISION THAT ALL WOMEN IN THE PHILADELPHIA REGION ATTAIN FINANCIAL WELL-BEING FOR THEMSELVES AND THEIR FAMILIES. WESI BRINGS TOGETHER GOVERNMENT, NONPROFITS, PHILANTHROPY, BUSINESS AND WOMEN WITH THE LIVED EXPERIENCES OF ECONOMIC INSECURITY AROUND A COMMON AGENDA AND ALIGNED ACTIVITIES, USING THE COLLECTIVE IMPACT FRAMEWORK. THE WESI NETWORK IDENTIFIES CRITICAL SYSTEMIC GAPS, ENHANCES THE COORDINATION AND CAPACITY OF ORGANIZATIONS DOING PROMISING WORK, AND BUILDS A COMMUNITY COMMITTED TO DATA-DRIVEN LEARNING.
