Explanation: The organization is a completely volunteer organization. They have been running underneath the threshold for filing the 990EZ for years and have been filing the 990N timely each year. Upon discussion regarding the 08/31/2018 fye filing, it was discovered that the organization had crossed the threshold for needing to file a 990EZ return vs the 990N. As the books had not been maintained in accounting software, this was discovered almost a year after the end of the fiscal year in question, the bank needed to be contacted to provide all documentation relating to deposits and expenses in order to properly build financial records to be able to file a return and report the activity for the proceeding 5 years on Sch A. Through the work of volunteers, this was done and the return prepared and filed, albeit late. There was no intention to be late, and to ensure the returns will be timely filed in the future, the organization has contracted with a paid bookkeeper to ensure the books and records are maintained going forward in a format to allow for timely and accurate filing.
