28 During the past fiscal year, September 1, 2017 through August 31, 2018, Touching Lives Worldwide successfully continued with the same programs and projects that were in place in the previous fiscal year Touching Lives Worldwide, Inc partners with a certified Dominican Republic non-profit organization known as God Is Touching Lives in the D R , Inc Both organizations work out of Dajabon, Dominican Republic, (which borders on Quanaminthe, Haiti) Through the partnership, both can do a lot to change the lives of poverty-stricken children as well as many dozens of adults They provide a special mission school for deaf children The deaf children have no other schools to attend because of their handicap They also have multiple classes to teach English and the Bible to children and adults of all ages They also provide food, as well as other help, for many homeless children that daily roam the streets looking for food or money The organization continues to change the lives of many adults & children in both Haiti and the Dominican Republic They help to save lives with emergency healthcare or other emergency assistance They associate with local churches to help the church as well as the needs of people that attend At their awesome 2018 Summer Camp, they had 172 needy children, ages 7 to 12 years old, attend and were given three good meals per day as well as having a great time learning, playing, and socializing with two other cultures Touching Lives Worldwide, through the partnership, provides 100% support to numerous Haitian children that live at their orphanage Food, clothing, shoes, healthcare, secure shelter, medical & dental care, and lots of love & affection is provided to each child To summarize, Touching Lives Worldwide is an organization that is very small, but, God has them doing BIG things They operate on a small budget, and, they have no paid employees in the U S A The C E O works as an unpaid volunteer and averages over 50 hours per week doing mission work for these organizations They are serving God and people in the following ways *Providing 100% of support for precious children at their orphanage in Quanaminthe, Haiti (medical, clothing, shelter, food, & much more!)*Providing a special school for deaf children from both Haiti & the Dominican Republic They have Haitian children that, each day, walk over one & one half hours one way just to come to the school *For over 8 years, they have provided super Summer Camps for hundreds of children, ages 7 to 12, which typically come from very poor homes & unthinkable poverty *They conduct numerous weekly ongoing English/Bible classes for children & adults These classes are popular, and, over the years, they have touched the lives of hundreds *They have helped or even saved the life of many children & adults that were sick, homeless, or had other dire needs*They have organized & hosted many teams, of volunteers, to go & serve in various ways, whether it was at one of our awesome summer camps or for medical, dental, or construction purposes In fact, they took a team of 26 people to work in Puerto Rico after the hurricane devastated that country * In addition to work in Haiti and the Dominican Republic, Touching Lives Worldwide serves dozens of people right here in the United States of America When they are called upon to help people, they respond in ways that meet the physical and/or spiritual needs of those people They advise, encourage, and comfort the people during their times of crisis (Grants \$ 121,007) If this amount includes foreign grants, check here . . . ► ☒	28a	37,671
