In the late Spring 2018, Southwest Border AHEC collaborated with Southwest Border Texas Junior College in establishing a summer enrichment program for college students interested in entering the health professions. This was 72 hour program designed to facilitate the entry of undergraduate students into medical and/or health care professionals schools. The curriculum, which consisted of 4 enrichment courses to enhance their academic skills and competitive standing, included critical thinking, science enrichment study skills, and communication skills. A total of 15 community college students enrolled in the program with 100% graduating. Payment for Stipend awarded to 15 college student for attending the College Enrichment Program of \$120 00 to 11 students, \$110 to 3 students and \$90 to 1 student
Honorarium for 4 College Instructors who taught the 4 courses during our College Enrichment of \$3400 00.
