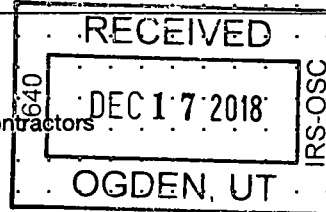

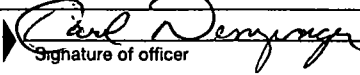

camp and provide camperships for needy families Our goal is that families should pay no more than they might pay for a typical child to attend

a similar program, even though we must provide much more intense supervision and adult support to meet the needs of children with a range

of disabilities We also provide camperships for children whose families cannot afford some or all of the family portion of the camp

regression when school starts in the fall Camp Sunshine trains and includes typically developing peers who participate throughout all activities

Peers not only model for the children with disabilities, but they learn and practice how to interact with other children whose communication and

movement may be very different than their own While spending time together, the children learn that they all play and enjoy the same things,

a valuable lesson for everyone

One hundred percent of net fundraising goes to experiences for the children A volunteer board runs all camp business operations and fund
