Throughout Vermont, Easterseals is dedicated to helping families by making a profound, positive difference in people's lives every day with offices located in Barre, Bennington, Burlington, Hartford, Middlebury, Morrisville, Newport, Rutland, Springfield, and St. Johnsbury. We are the leading agency in the state, working with the Department for Children and Families (DCF) to find family-centered solutions to problems. Many children suffer not only from the effects of their disabilities, but also from abuse, neglect, bullying, and lack of sufficient help and understanding. Easterseals is known for finding practical, realistic solutions and helping birth, foster, and kinship parents understand and work with their school systems. We empower parents to be more effective in teaching, listening to, and understanding their children's needs. We offer direct assistance to families to improve the situations they are dealing with Child & Family Support. Easterseals VT empowers and assists parents and children to improve their lives. At the heart of all we do is our belief that families can, with sufficient assistance, address their problems and be safe and healthy within their communities. Easterseals VT has earned a reputation for being the lead agency in the state in promoting family-centered practices for social services.
