

There is a daily review of cash management procedures to minimize the cash on hand. Monthly financial statements are submitted to senior management which include budget vs actual results, key drivers, and trends and audits are performed by the internal auditor. Many of our grants are cooperative agreements which require substantial involvement and monitoring by the respective federal agency. Periodic on site compliance monitoring reviews of subrecipient programs and financial operations is conducted. Further monitoring of findings is performed until deficiencies have been resolved. Annually, a Single Audit is conducted by the independent accountants and a negotiated indirect cost rate agreement is filed and approved by our regulatory cognizant agency.

State courts and child welfare agencies fund this project. Education Projects. In collaboration with the Education Law Center and the Juvenile Law Center, the ABA formed the Legal Center for Foster Care and Education in 2007 to provide national advocacy on policy matters affecting the education of children in foster care. Staff from the ABA have led efforts in jurisdictions across the US to convene child welfare agencies, local school district leadership and judges together to plan for and implement supports that allow children in foster care to maintain access to the same school despite changes in home placement.
