The mission of BAAY is to enrich the lives of children through the exploration of the arts. We fulfill this mission by offering programs in choir, theater arts, dance, visual arts, music, and many other dynamic classes. Through our programs we create community, and teach children confidence, character, and creativity.

ARTS ACADEMY FOR YOUTH: Combination code 611610 and code 711110. Revenue from tuition for our theater programs is 611610, and the theater revenue from production of our programs is 711110.

The objective of our Arts Academy for Youth program is to provide children with a safe community in which to learn vocal and instrumental music, theater, art, and dance techniques. Through this program, we foster and support respect, cooperation, decision-making, self-discipline, and self-confidence in young people.

BAAY offers visual and performing arts classes to children ages 5-17 at our Arts Academy for Youth. We offered 30 programs this fiscal year, comprised of 1292 program hours. 22 of those programs culminated in performances, including the full musicals Oliver!, Chicago, Really Rosie, Shrek, Once Upon a Mattress, The Snow Queen, Xanadu, and many others. An estimated 6727 children and adults attended the children's productions. These productions were part of 78 events held at our theater in support of our mission. 355 unique students enrolled in our programs, with 627 registrations in total. BAAY was able to support the participation of 51 students in our programs by giving them tuition scholarships.

BAAY PRESCHOOL:

BPOTA offers 2.5-5 year olds a unique early learning opportunity to develop cognitive, emotional, social, and multi-sensory skills in an environment rich in the arts. We mix academics and arts in order to serve the whole child. Our arts-based preschool provided 180 days of care to 46 individual children. BAAY was able to support the enrollment of 4 of those children by providing their families with tuition scholarships.

EDUARTS:

Our EduArts program carries the philosophy and learning environment of our Arts Academy for Youth into 14 local public and private elementary schools. Through this program we offer performing and visual arts classes before and after regular school hours, on school campuses, to supplement students' educations and provide child care. 724 students participated in our programs this fiscal year, in 69 unique plays, arts classes, and music classes. BAAY was able to support the enrollment of 84 of those children by providing their families with scholarships to cover the cost of their children's tuition.

Our scholarship program serves those families in our community who are undergoing financial hardship, whose children wish to participate in our arts programs. Our organization solicits donations to our scholarship fund, those funds are then made available to families whose children want to participate in our programs: kids who would not otherwise be able to participate for lack of money. We track internally the funds donated to our scholarship fund, the recipients, when the scholarship was granted, and for what programs. We know that in FY 2017 we were able to provide 139 students with \$25,263 in combined tuition support through the program, as shown in Part III columns (b) and (c). The scholarship program is advertised publicly, and is available to anyone regardless of race, ability, gender, or any other factor. To be considered for a scholarship, the legal guardian of a child wishing to participate in one of our programs must fill out a BAAY scholarship application. The application expresses the financial need of the family, and is otherwise based on the honor system. Once an application is completed, we evaluate our financial capacity to grant the request, and then grant requests based on a model of "as much as we can do". No applicant is turned away unless granting the scholarship would compromise our fundamental ability to function as an organization. Scholarship amounts range from 20% to 100% of the tuition cost of a program.

Part I, Line 6: BAAY theater productions are staffed almost entirely by volunteers (typically the parents or guardians of the students in the show). This volunteerism raises our estimate considerably. 22 productions annually, made up of an average of 78 show nights, staffed by at least 3 parents per night. Teaching assistant volunteers accompany every EduArts Enrichment, class, of which there were 69. Accounting for repeat volunteers, we estimate 162 volunteers annually, in addition to our interns and wider community volunteers.
