THESE PROGRAMS FOCUS ON ADDRESSING SAFETY HAZARDS AND PROVIDING TRAINING AND INFORMATION AND ASSISTANCE TO MEMBERS. A KEY COMPONENT OF SERVICES OFFERED TO WECA MEMBER COOPERATIVES IS THE WIDE VARIETY OF EDUCATIONAL PROGRAMMING DESIGNED TO HELP CO-OP EMPLOYEES AND ELECTED DIRECTORS BETTER MEET THEIR RESPONSIBILITIES. FARM REWIRING - MANY AGRICULTURAL FACILITIES IN THE UPPER MIDWEST HAVE BEEN AGING, AND REINVESTMENT IN THEM HAS BEEN MADE MORE DIFFICULT DUE TO LOW MILK PRICES.
