THE CPA WAS SLOW TO COMPLETE THE FINANCIAL STATEMENTS, AND THE CPA TERMINATED THEIR SERVICES WITHOUT PREPARING THE FORM 990 AND WITHOUT FILING FOR AN EXTENSION OF TIME TO FILE THE FORM 990. THE CALIFORNIA ASSOCIATE STAFF NEEDED TIME TO FIND A QUALIFIED CPA FIRM TO ENGAGE FOR THE PREPARATION OF THE FORM 990. THE NEW CPA FIRM WAS ENGAGED NOVEMBER 1, 2019 TO PREPARE THE ORGANIZATION'S FORM 990 FOR THE YEAR ENDED AUGUST 31, 2018.

PRIOR TO THE FORM 990 BEING SUBMITTED, OFFICES WERE CLOSED DOWN DUE TO COVID-19. AS OPERATIONS ARE BEGINNING TO RETURN TO NORMAL, WE HAVE REALIZED THAT THE FORM 990 STILL HAD NOT BEEN FILED. THE ASSOCIATION HAS SINCE IMPLEMENTED NEW PROCEDURES TO ANNUALLY MONITOR THE FILING DEADLINE TO ENSURE THAT OUR FORM 990 IS COMPLETED AND FILED TIMELY GOING FORWARD.
