Draft ED review evaluation is reviewed by the Executive Committee (and/or the ED performance and salary review subcommittee). Review evaluation includes rating of the ED key responsibilities, along with comments and examples to support each rating. Results are presented to full Board for approval. Board Chair conducts final review evaluation discussion with ED. A copy of the final review is sent to the Assistant Dean for Student Affairs for submittal of the University Appraisal Form to the Engineering HR office. Board Chair provides a copy of the completed evaluation to the ED to read and review before the scheduled discussion. Board Chair signs the evaluation. The ED provides any final comments, if desired, and signs evaluation. Executive Committee (and/or the ED performance and salary review subcommittee) recommend whether salary increase is appropriate, along with recommended salary increase amount. Full Board approves/disapproves salary recommendation.
