The conflict of interest policy contained in the NAIFA employee handbook covers all NAIFA employees and requires employees to immediately notify their supervisors of a potential conflict of interest. NAIFA management reserves the right to prohibit any activity that may constitute a conflict of interest policy and employees who participate in practices that constitute a prohibited conflict of interest are subject to a disciplinary action.
