The Team achieved Silver Medal Club Recognition in USA Swimming's Club of Excellence Program. One swimmer qualified and participated in US Summer Nationals, 4 participated in US Summer Junior Nationals, 4 more athletes qualified for the following year's Summer Junior Nationals, and 13 qualified for US Winter Junior Nationals. One athlete was selected for the US National Select Camp. TIDE also hosted 4 USA Swimming sanctioned meets with an average athlete attendance of 600 athletes per event.
