SAF brings students and farmworkers together to learn about each other's lives, share resources and skills, improve conditions for farmworkers, and build diverse coalitions working for social change.

Into the Fields Internship & Fellowship - Twenty-five Into the Fields interns and fellows conducted outreach to over 5000 farmworkers in rural areas of the Carolinas. The students presented know your rights trainings, organized women workers, conducted occupational health and safety trainings, taught ESL, mentored out of school youth, and transported and interpreted for workers at appointments. They also worked deeply with workers at 6 labor camps through documentary and theater, coordinated a pilot project providing computers, hotspots and wifi for four labor camps, and shared their experiences with the larger public through blogs and presentations.

4b (Code) (Expenses \$ 182,349 including grants of \$ 13,100) (Revenue \$ 5,980)

From the Ground Up - Six Solidaridad interns worked with SAF during the academic year to educate, advocate, and organize in support of farmworker justice on their campuses and in the larger community in NC. Several interns created pesticide safety videos for farmworker children and they all participated in a chicken coop build with a farmworker family. SAF conducted presentations on issues ranging from child labor to food security to the historical context of agricultural workers in the US. We continued to co-coordinate a farm labor mapping project, Dia de los Muertos event, Farmworker Institutes in both NC & SC, and featured the new film Dolores during National Farmworker Awareness Week.

Levante Leadership Institute - Ten core youth from Eastern NC participated in the Levante Leadership Program, engaging in trainings, retreats, conferences, and rallies focused on education and child labor. Through a documentary arts project, the youth explored themes of identity, culture, hopes, and stories of farm work, which were curated into an exhibit that was displayed at the Center for Documentary Studies.

The salaries of the executive director and the assistant director are determined by a pay schedule added to the organization's personnel policies after SAF's last union contract (8/31/16) negotiation. The Organizational Capacity Committee, which is made up of several Board and staff members, reviewed the schedule which mirrors the union contract in the way it determines initial salaries based on experience and annual pay raises. SAF has an additional policy that caps the top executive's salary to no more than twice that of the lowest paid employee. The full board approves changes in personnel policies as recommended by the OC committee. All other employees are covered by the three year union contract.
