The Region II IDRA EAC-South is a federally funded program that IDRA operates to develop local capacity among the approximately 3,000 school districts and approximately 29,000 schools in the region and desegregate schools in the area of race, national origin, sex and religion. The program implements a coherent, research based technical assistance and training plan in Region II through strategic approaches, service delivery, and web-based and on-site approaches. Project recipients include SEAs and LEAs in Region II states which include Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Texas, Virginia and the District of Columbia.

4b (Code:) (Expenses \$ 794,331 including grants of \$ 25,000) (Revenue \$)
The development fund provides resources for mission and priority program services not supported by external funding and for development of new programs. It facilitates the dissemination of knowledge about best teaching practices in classrooms with diverse students, the creation of materials that specifically address the needs of traditionally underserved students, and research on school finance and other indicators tied to the quality of education that all students receive. On average, this fund supports educational services that have a direct impact on students and teachers. In 2018, 1,016 school administrators and parents were served directly. These services have a national focus with particular interest in Texas schools and the creation of equitable educational opportunities for all children.

The STAARS project is a three-year federally funded program designed to strengthen and sustain the leadership pipeline through a program of transformational professional development. Secondly, the program supports and informs a recruitment and selection strategy to select school leaders who have a disposition and skills for a turnaround campus. Thirdly, the program has as its goal to provide professional development and mentoring support to principals and turnaround team leaders. Additionally, the program supports central administration and support staff with professional development on strategies that retain effective leaders and replace ineffective leaders.

T-3 - The Teachers for Today and Tomorrow (T-3) is a five-year project funded by the U.S. Department of Education Transition to Teacher program. Through T-3, IDRA is selecting, recruiting and retaining competent teachers in multicultural settings who have a passion for teaching and making a difference, developing a curriculum to certify teachers in bilingual/ESL and STEM subjects in mostly Latino communities, and providing a comprehensive online and personalized support system to retain teachers for a minimum of three years. T-3 is also expanding the candidate pool to include paraprofessionals, a basic feature of a "grow your own" teacher recruitment approach.

REENERGIZE - In this program, IDRA is working in partnership with Edgewood ISD, Southwest ISD, and the College of Education and Human Development at the University of Texas at San Antonio to combine expertise in preparing principals in an unprecedented way to support high-poverty, low-performing schools to improve achievement of students. Edgewood ISD and Southwest ISD in the Westside of San Antonio will build and strengthen the leadership skills of current principals and leadership teams to begin a new era of change marked by systemic, structural and instructional transformations.

CCVYP - The Coca-Cola Valued Youth program, funded by the Coca-Cola Foundation, provides training, technical assistance, monitoring and evaluation to schools, implementing a cross-age tutoring program designed to address dropout rates.
