Access Denver, Colorado Leadership Alliance, Impact Denver, Leadership Alumni Network, Leadership Denver, Civic DNA, cDNA Fellows, Colorado Experience, and Mobility Choice are designed to prepare and connect leaders from the business and civic communities to strengthen Colorado's future. Access Denver exposes senior-level Denver executives to the influential people and critical issues of the Denver area, providing an exclusive two-day introduction to the city's business and community landscape. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenues of \$125,300 and expenses of \$74,772 for a program net of \$50,528. Colorado Experience is a two-day program designed to promote dialogue relating to statewide business and policy issues. The program provides an opportunity for emerging and executive leaders to explore Colorado's regional issues and to strengthen collective vision and collaboration in our communities. The program takes participants to a different city in Colorado each year. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenues of \$99,850 and expenses of \$115,789 for a program loss of (\$15,939). Impact Denver builds confidence and leadership skills for young professionals while introducing them to topics of significance to the region. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenue of \$261,735 and expenses of \$191,641 for a program net of \$70,094. Leadership Alumni Network ties together 2,300 alumni of the Leadership Foundation's programs, who represent the Denver Metro region's business, civic, and community leaders. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenue of \$34,533 and expenses of \$101,039 for a program loss of \$66,506. Leadership Denver is an 11-month program for active leaders focused on assuming civic leadership roles in the Denver Metro community. Leadership Denver is a balance of in-depth issues seminars, retreats, and a group community service project. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenues of \$282,940 and expenses of \$183,425 for a program net of \$99,515. Civic DNA and Civic DNA Fellows represents inclusivity, collaboration, shared vision, and responsibility for today's leaders in Colorado. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenues of \$170,800 and expenses of \$170,295 for a program net of \$505. Mobility Choice is working to maximize existing investments in the Colorado transportation system by leveraging technology to plan for future workforce and employer mobility needs, thereby increasing economic opportunities and quality of life. Inclusive of contributions made to the program in fiscal year 2018, this program generated total revenue of \$192,650. Program expenses totaled \$167,343 during 2018. Community partnerships program expenses totaled \$29,757.
