Services for adults include detox, residential treatment, and outpatient treatment. Services for adolescents include residential and outpatient Adolescent Substance Use Treatment The Campus. The Campus provides a continuum of substance use treatment for youth between the ages of 13 to 17. The Campus residential program provides individual and group therapy, substance abuse education, life skills training, anger management, an on-site school, and family counseling. A therapeutic camp enhancement was launched in the fall of 2014. In FY18, seven weekend-long therapeutic camps were provided for youth in the residential unit. The project also provided biweekly, one-hour therapeutic counseling sessions to maximize the camp experience. Approximately 112 youth had the opportunity to experience adventure activities such as horseback riding, Ropes course, zip line, swimming, life skills teambuilding, orienteering and various sporting games.

Intellectual and Developmental Disability Services (IDD) Disability Services offers group homes, adult day activity centers, supported employment, respite and information and referral services for individuals and their families. MHMR Visions provided funds for enriched services for individuals served by MHMR included community outings and enrichment activities to help people participate actively in the community. Day Activity Centers offer day habilitation services and employment training for almost 300 adults. Visions provided weekly music therapy and recreational art classes and Special Olympics and gardening supplies. Community outings included trips to Texas Ranger baseball games, Medieval Times, the Texas State Fair, and specialized camps.

Early Childhood Intervention (ECI) ECI offers comprehensive services to families with infants and toddlers between the ages of birth to 36 months who have developmental delays or disabilities.
