Vineyard Early Childhood Center achieved the following: (1) maintained the rating of a "Four Star" quality center through Ohio's "Step Up to Quality" program, which recognizes excellence in early childhood education program; (2) continued development of VECC including new technology in the center, new curriculum, and continued focus on professional development for the staff; (3) Awarded City of Columbus ESC Grant to offer kindergarten prep services to PreK children; (4) maintained a 65% rate of enrollment of children from low to moderate income families (measured by eligibility for Title XX), reflecting continued diversity of families served; and (5) maintained six all-day classrooms, for ages six weeks to five years (plus half-day, pre-school during academic year) and, against licensed capacity of 104 children per day, had average daily attendance of 80 children.

**4b** (Code: ) (Expenses \$ 612,902 including grants of \$ ) (Revenue \$ 60,091)  
The Organization's after-school and summer programming for school-age children is organized in grades K-5, known as "AS K-5" and "Vineyard Summer Program," respectively, and grades 6-12, which has been renamed "AS MS/HS". These programs achieved the following: (1) First year funding through 21st Century Learning Center which allowed the 6th-12th grade programming to expand greatly, including offering summer employment opportunities to high school students and reintroducing summer programming to middle school students. (2) Enrollment jumped from 40 to 63 and ended the summer at 53 students enrolled. The program continued its focus on employment readiness with a partnership for internships with Gap, Inc. (3) Maintained partnerships with Future Ready and use of Learning Circles and DESSA tools for academic and social/emotional improvement. (4) The Vineyard Summer Program offered 57 students 100% free summer services for up to 8 weeks while maintaining its successful partnerships by bringing in two Americorps/VISTA Summer Associates. (5) Overall - Vineyard After School programming saw a slight increase in enrollment for services K-5th grade with 56 participants and 6th-12th grade with 64 participants, for a total of 120 youth being served each week. (6) Year 3 of "One Child One Community" Mentoring Program: continued to progress toward goal of 120 mentors for 180 students; Annual spring clean-up and beautification project grew to 15 schools (from 8) with over 1,000 volunteers (from 450).

The Organization's Social Outreach Programs achieved the following: (1) Continued with a full-time immigration attorney (pursuant authorization granted in 2011 by U.S. Department of Justice, Executive Office for Immigration Review, Board of Immigration), hosted community awareness events and trainings, hosted volunteer awareness events and trainings, and continues to host a volunteer-driven weekday clinic for immigration questions and services; (2) average number of programs/classes offered per month increased from 42 to 63; (3) average attendance at classes and programs grew to 4,635 per month (12% increase); and (4) volunteers contributed over 5,000 hours of service in programs and classes.

Form 990, Part III, Line 1d: The Organization's Sports & Exercise Programs (Expenses \$187,435) (Revenue \$105,942) saw a decrease in participation, from 2,989 per month to 2,538 per month (15% decline). The largest decline came for youth league basketball which has heavy competition from city sports leagues and other non-profit and for-profit youth programs. The average number of volunteers increased from 40 to 53 per month, contributing to nearly 1,400 hours of volunteer service. Additionally, Vineyard Athletics extended its formal partnership with NOVA Village for AAU basketball programming and launched 24 AAU basketball teams (2 more than prior year). The high school teams generated over 30 college scholarship offers to its participants.

Form 990, Part III, Line 4d: The Organization's Free Health Clinics (Expenses \$95,085) (Revenue \$0.00) achieved the following:

- (1) continued a partnership with Lower Lights Christian Health Centers (a federally qualified health center) to utilize the facilities at the organization's two free health clinics locations (a rented facility in the Weinland Park community and at the organization's main location);
- (2) the total patients served was 1,308 (1% increase) despite the continued decline in free clinic patient visits across the State of Ohio; and
- (3) organized over 140 volunteers with total of 1,214 professional hours served and 1,562 clinic support hours served for a total of 2,776 volunteer hours provided (conservative overall value of services rendered by volunteers exceeds \$211,000).

Part V, Line 1b and 2a: The Organization acknowledges that, without an explanation, confusion could result from the Organization reporting "0" on these lines while at the same time reporting compensation, salaries, wages, pension plan contributions, other employee benefits, and payroll taxes (collectively, "Personnel Expense") in Parts VII and IX. To alleviate any potential confusion, the Organization wishes to clarify that it receives contract staffing services from Vineyard Christian Fellowship of Columbus, an Ohio non-profit corporation dba Vineyard Church of Columbus ("Vineyard Columbus"), whereby Vineyard Columbus provides to the Organization, on an exclusive basis, employees of Vineyard Columbus to fill the Organization's staffing needs. Accordingly, although the Organization directly employs nobody, the Organization does reimburse Vineyard Columbus for all Personnel Expense incurred by Vineyard Columbus in connection with the employment of staff provided by Vineyard Columbus to the Organization. The Organization records such reimbursement as Personnel Expense, but Vineyard Columbus, as the direct employer of such staff, is responsible for all reports and filings required by the IRS and any other federal, state, and local authorities related to such employment.

All appraisals are reviewed, compared, and evaluated by a Salary Review Committee (the "SRC"), which is appointed by and under the jurisdiction of the Vineyard Columbus Church Council (i.e., its Board of Directors). The SRC is made up of Vineyard Columbus church members who are financially disinterested and independent of Vineyard Columbus staff, as required by Vineyard Columbus' code of regulations. The SRC's review includes the use of multiple national comparative salary reviews for churches (which are obtained by the Vineyard Columbus human resources department and provided to the SRC), with all positions classified into comparative salary ranges. Based on (1) a target average merit percentage established by Vineyard Columbus' Coordinating Team, (2) the employee's performance, and (3) the employee's current salary location within the predetermined salary range for the employee's position, the SRC, through a joint deliberative process that is contemporaneously substantiated in writing, determines and recommends adjustments for each employee. The SRC's recommendations are communicated in writing in the form of a spreadsheet that the SRC compiles over the course of its deliberations and gives to the Vineyard Columbus Senior Pastor, Executive Pastor, and human resources department. As required by Vineyard Columbus' Code of Regulations, the SRC's recommended adjustments are binding as to members of the Coordinating Team. For all other positions (including the Organization's Executive Director), the Vineyard Columbus Senior Pastor and Executive Pastor review and approve in writing the spreadsheet provided by the SRC. Any changes to the SRC recommendations desired by the Senior Pastor or Executive Pastor do not become effective until they have been presented to the SRC and resolved by mutual agreement. All such discussions and decisions are contemporaneously substantiated in writing.
