AAS RECEIVED AN INITIAL DISBURSEMENT OF \$932,000 AND WCC RECORDED TEMPORARILY RESTRICTED REVENUE. THE UNEXPENDED FUNDS CONTINUE TO BE MANAGED BY AAS IN A SEPARATE BANK ACCOUNT SET UP FOR WCC. FUNDS WILL BE DISBURSED BY AAS TO WCC UPON RECEIVING WRITTEN REQUEST FOR REIMBURSEMENT OF EXPENSES.

WCC FILES INCOME TAX RETURNS IN THE US FEDERAL JURISDICTION AND IS NO LONGER SUBJECT TO U.S. FEDERAL INCOME TAX EXAMINATIONS BY TAX AUTHORITIES FOR YEARS BEFORE 2015.
