**Family Mentor Teams that work with particular immigrant families. In FY 2018 we had 15 FMTs with roughly 150 participants and volunteers.**

**• Meeting immigrant needs: CANMP meets immigrant needs for housing, language, transportation, employment, and basic essentials through  
partnerships with local institutions, special events, and programs.**

**• Educating the broader community: CANMP's staff and volunteers offer programs and give presentations to community groups, schools, and  
other audiences to educate people about the challenges that immigrants face and the benefits they bring to our area.**

**These three program services above constitute roughly 80% of our Executive Director's time and 100% of our interns' time = \$18029**

**• Direct services: We provide translation and interpretation services for community organizations and agencies. \$3089**
