GRANTS IN ISRAEL We made significant financial grants to the Hand in Hand Center in Israel which helped lay the groundwork for a new integrated school in the Israeli city of Upper Nazareth, helped create a new version of bilingual and multicultural early childhood education program, expanded the Jewish-Arab shared communities program and offered scholarships to over 150 needy students in the Hand in Hand schools. These grants also enabled growth of the 3 younger Hand in Hand schools where enrollment has grown. They also provided support for the alumni program for graduates of the Hand in Hand schools to provide them with forums to stay active in promoting Jewish-Arab partnerships and coexistence
