Our drop-in and long-term residential programs provide hot meals, safe shelter, showers, clean clothing, counseling, spiritual mentorship, education, career counseling and long-term recovery programs that help people transform their lives. Cityteam has the capacity of providing 411 beds per day for men, women, and children depending on upon location. Our dining halls provide over 1,849 meals each day. Our primary locations are San Jose, San Francisco, and Oakland in California. We are also located in Chester, Pennsylvania and Portland, Oregon.

Most of the people in the countries where we work live in extreme poverty. We are committed to the inseparable nature of expressing our love for God by demonstrating His love to our neighbors as a part of both being and making disciples. Cityteam International was discontinued as a program under Cityteam Ministries as of June 30th, 2018. Cityteam International was spun-off to form a new organization call New Generations. The calling of New Generations is to train national leaders to launch and sustain Disciple Making Movements and help like-minded ministries around the world to do the same.
