The Institute helps support these centers through a monthly pledge to Nyingma Centers, and monitors their program accomplishments and use of funds through regular reports and an annual, week-long meeting that takes place in July, attended by representatives of the Nyingma Institute, Nyingma Centers, and each foreign educational center.
