LRH encourages department managers and senior managers to serve on local boards. LRH also works with local businesses to promote health and wellness. We work with schools to address the health of our young community members, and we work with our local safety providers to promote safety and to help prevent injuries.
Part III, Line 4	Patient accounts receivable are stated at the amount management expects to collect from outstanding balances. Management provides for probable uncollectible amounts through a charge to operations and a credit to a valuation allowance based on its assessment of individual accounts and historical adjustments. Balances that are still outstanding, after management has used reasonable collection efforts, are written off through a charge to the valuation allowance and a credit to patient accounts receivable. In evaluating the collectibility of accounts receivable, the Hospital analyzes past results and identifies trends for each major payor source of revenue for the purpose of estimating the appropriate amounts of the allowance for doubtful accounts and the provision for bad debts. The adequacy of the allowance for doubtful accounts is regularly reviewed. For receivables associated with services provided to patients who have third-party coverage, an allowance for doubtful accounts and a provision for bad debts are established at varying levels based on the age and payor source of the receivable. For receivables associated with self-pay patients, the Hospital records a provision for bad debts in the period of service based on past experience indicating the inability or unwillingness to pay amounts for which they are financially responsible.

The 2012 Median Household Income for the area is \$52,729, which is lower than the New Hampshire median income of \$59,470 but higher than the national median income of \$49,599. Median Household Wealth and Median Home Values likewise are below State and above national values. The portion of the population in the County over 65 is 15.9%, above the New Hampshire average of 13.5%. In the County this population is anticipated to increase 1%, whereas for New Hampshire as a whole, the female population age 15 to 44 is anticipated to decline as a rate of just over 2%.
