The residence provides permanent housing to six mentally challenged veterans. The veterans remain in active treatment with the U.S. Department of Veterans Affairs (VA) while they reside in the house. In addition to our permanent living house, we have three transitional living houses which we own and operate in concert with the VA. Our transitional living houses provide room for twenty-four veteran residents. The residents stay an average of seven months and over the last five years, approximately 199 former residents left the houses with 71% having found living accommodations and / or jobs.

VSF, as part of its ongoing service to veterans, provides funding in the form of grants for veteran-related projects throughout the United States. VSF gives priority to matching fund projects.
