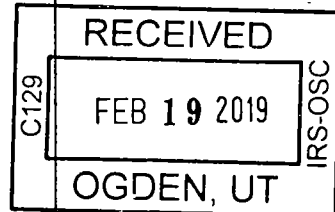



The majority of our spending goes directly to schools in Zimbabwe where we pay school fees and required expenses for 38 orphans and vulnerable children. This fiscal year, we paid for 10 primary and secondary students to attend local day schools (\$12,677), 11 young adults to attend technical schools (\$41,220), 14 students to attend boarding schools where we also covered their room and board (\$41,220). We also supplemented scholarships given to 3 college students so they could attend schools (1 in Zimbabwe and 2 in the United States). We covered medical expenses and supplemental nutrition for all of these children (\$4379) and provided various teambuilding and incentives throughout the year, including dinners, awards, meetings and outings (\$6,361).

Most of our additional expenses went toward travel to monitor programs (\$3,178), bank fees (\$1002) and taxes/filing fees (\$310). The remaining \$2368 includes Internet fees, phone, office supplies and other odds and ends.
