Funded by the U.S. Economic Development Administration and the Claude Worthington Benedum Foundation, the NextUp WV program is being delivered in partnership with three sub-awardees: the Chemical Alliance Zone, the Center for Applied Research & Technology and the INNOVA Commercialization Group. The project began 9/28/17 and will end 9/28/19.
