Accordingly, \$78,750 was included in Mr. Steigmeyer's 2017 W-2 taxable wage which was previously reported on Schedule J, Part II, Column C of the Hospital's Form 990 filing for fiscal year ending September 30, 2015. In accordance with IRS instructions, this amount has been included in Schedule J, Part II, Column B(III) and Column F. There were additional contributions to Mr. Steigmeyer's 457(f) plan for fiscal years ended September 30, 2015, 2016, 2017, and 2018 of \$115,000, \$120,000, \$125,000, and \$162,500 respectively. Each contribution plus earnings will be reported in Mr. Steigmeyer's W-2 after a three-year vesting period. The amount included in Mr. Steigmeyer's deferred compensation amounts in Schedule J, Part II, Column C include the \$125,000 contribution to his 457(f) plan plus \$26,044 of earnings.
