For tax positions meeting the more likely than not threshold, the amount recognized in the financial statements is the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement with the relevant tax authority. The Foundation had no material unrecognized tax benefits and no adjustments to its financial position, activities or cash flows were required. The Foundation does not expect that unrecognized tax benefits will increase within the next twelve months. The Foundation did not record any interest or penalties on uncertain tax positions in the Statements of Financial Position as of September 30, 2018 and 2017 or the Statements of Activities for the years then ended. If the Foundation were to incur any income tax liability in the future, interest on any income tax liability would be reported as interest expense and penalties on any income tax liability would be reported as income taxes.
