Procedures for monitoring the use of grant funds outside of the US: As Givology was founded on the principle of transparency, we require that each of our grassroots partners adhere to the strictest form of reporting and accountability. The main methods that we monitor entail:

Quarterly progress reports in the form of letters from students, photos, video clips, student transcripts, receipts of tuition payment & other educational expenses, description of activities by the program manager or school administrator, among other updates. We maintain regular contact with our grantees to ensure that operations are proceeding as anticipated, and cross check information with multiple sources to verify.

Visit by our fellows and affiliated members: Through our partnerships with universities and other foundations, we leverage our volunteer network for site visits. Each year, do regular due diligence calls throughout the year to confirm receipt of funds and impact generated.

If a grantee receiving our funds does not meet our standards for accountability or fail to deliver comprehensive quarterly reports, we suspend the partnership and the disbursement of funds.

Procedures for monitoring the use of grant funds inside of the US: As Givology was founded on the principle of transparency, we require that each of our grassroots partners adhere to the strictest form of reporting and accountability. The main methods that we monitor entail:

Quarterly progress reports in the form of letters from students, photos, video clips, student transcripts, receipts of tuition payment & other educational expenses, description of activities by the program manager or school administrator, among other updates. We maintain regular contact with our grantees to ensure that operations are proceeding as anticipated, and cross check information with multiple sources to verify

Visit by our fellows and affiliated members: Through our partnerships with universities and other foundations, we leverage our volunteer network for site visits. Each year, we have teams visiting approximately 5-7 of our grantees on a rotating basis to provide consulting work, conduct due diligence, and assess the progress of our grants.

If a grantee receiving our funds does not meet our standards for accountability or fail to deliver comprehensive quarterly reports, we suspend the partnership and the disbursement of funds.
