The St. Vincent de Paul Pharmacy, which opened in 2018, is the first pharmacy in the state of Texas that provides lifesaving medications to the general public. The pharmacy provides prescription medications to uninsured, lower-income individuals free of charge. When it comes to poverty and access to healthcare in the North Texas region, the statistics are staggering and speak to the extraordinary need for the SVdP Pharmacy. Nearly 700,000 people in the nine-county service area lack health insurance; 500,000 Dallas County residents are uninsured. According to the Center for Public Policy Priorities, nearly 50 percent of women ages 15-44 in Dallas County do not have health insurance. Despite diagnoses on the rise for diabetes, heart disease and other chronic conditions, many people are unable to afford health-sustaining prescription medications like insulin, blood pressure medicine and asthma inhalers. Paying for these medicines might mean they can't pay for rent, utilities or food for their families. The goal is to help our neighbors sustain their health while they work towards a better life, providing a higher quality of life and reducing early morbidity. The pharmacy also can bring down the cost of caring for the uninsured through our hospital systems. The top three medications dispensed by the SVdP Pharmacy treat high blood pressure, high cholesterol and diabetes - all of which impact heart health. The second largest class of medications dispensed is behavioral medications.

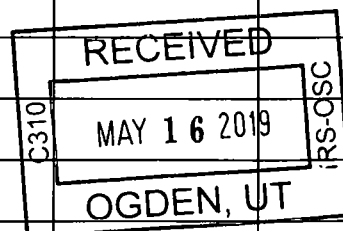
