East of the River tobacco free project (EoR) With funding from DC Health, BDC implemented the EoR project to provide tobacco cessation services and support to pregnant women and to smokers in households with children ages 0 to 17. in wards 7 and 8, which have the district's highest smoking rates estimated at 37%. BDC provided services and techniques to 2,502 smokers to assist them with quitting or reducing smoking. Specifically, BDC enrolled 33 participants in "Text-to Quit," distributed 2,447 "1-800 Quitline Cards;" enrolled 4 participants in "1:1 Smoking Cessation session;" and provided 8 "Group Cessation sessions to 89 participants. In 2018, BDC provided five Ask Advise Refer (AAR) trainings to 44 participants which included, physicians, nurses, and social workers. Trained participants utilized the AAR model as a tool to encourage their clients to quit/reduce smoking.

Breathe EASY Asthma Home Visiting Program Breathe EASY implemented this intervention to reduce emergency room visits, and hospitalizations for asthmatic children and to assist household members with smoking cessation. Breathe DC staff conducted a walkthrough of homes to identify environmental asthma triggers and assist families with trigger reduction of pests, dust mites, mold and environmental tobacco smoke. The child's primary caregiver and other relatives receive a targeted educational intervention to assist with reducing factors in the home environment that can aggravate asthma attacks in children. In 2018, we conducted 139 home visits from referrals from the four partnering managed care organizations.
