DURING 2018, THE NETWORK CONTINUED PARTICIPATION IN IMPLEMENTATION OF OHIO'S ADOPTEE RECORDS LAW, THROUGH WHICH OVER 12,500 RECORDS HAVE BEEN RELEASED, HELPED TO DEVELOP AND SUPPORT LEGISLATION TO ADDRESS SIBLING RIGHTS IN OHIO, MAINTAINED ACTIVE INVOLVEMENT ON THE OHIO ADOPTION PLANNING GROUP, AND SUPPORTED VARIOUS LEGISLATIVE INITIATIVES INCLUDING ONE TO MAKE POLICE OFFICERS MANDATED CHILD ABUSE REPORTERS. 5 PROFESSIONAL AND STAKEHOLDER HUB - THIS PROGRAM CREATES A COMMUNITY FOR PROFESSIONAL TRAINING, DEVELOPMENT AND COLLABORATION FOR ALL OF THOSE WHO WORK WITH AND FOR THE ADOPTION AND FOSTER CARE POPULATION. IN 2018, THE NETWORK FACILITATED AND PROCTORED 40 CHILD WELFARE PROFESSIONAL TRAININGS IN PARTNERSHIP WITH THE OHIO CHILD WELFARE TRAINING PROGRAM WITH CUMULATIVE ATTENDANCE OF 644 INDIVIDUALS. IN ADDITION, THE NETWORK LED THE ADOPTION AWARENESS COALITION WITH 22 ORGANIZATIONAL MEMBERS IN A LEARNING COMMUNITY FORMAT. TWO (2) COLLEGE STUDENTS WERE MENTORED IN THE SCHOLARS PROGRAM AND THERE WERE 4 UNDERGRADUATE AND GRADUATE INTERNS.
