School Without Walls/Next Generation Professional Leaders Initiative - These non-formal training programs are designed to train, equip, and mobilize the Next Generation of Christian leaders in Eurasia to transform their nations for Christ. Through SWW/NGPLI, young people receive biblically based training while participating in practical ministry outreaches in their communities. During 2017-2018, SWW trained a total of 1,700 students in 13 countries of Eurasia, and Israel. Also, NGPLI trained 8,300 young professionals in six different countries. We estimate that more than 800,000 people were impacted for Christ through this program in 2017-2018.
