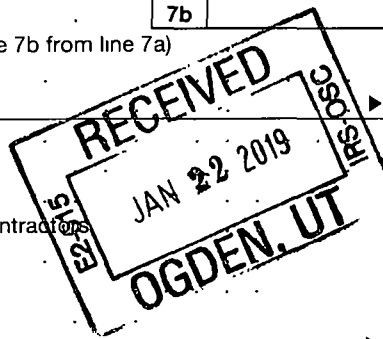

The Board reviews and approves the statements on a regular basis. A club member does an independent review of the records after the end of the fiscal year.
