 Providing free food to the needy both on a walk-in basis (to our pantry) and via delivery to those unable to pick-up. The total value of food provided (estimated) is \$ 133,776 which includes \$ 21,552 of food purchased with our cash donations and \$ 112,224 of in-kind donations from local food banks, retailers, our own parishioners, and others. This food was provided to 2730 households containing 7860 individuals. We received no revenue from this activity.

4b (Code:) (Expenses \$ 70,400 including grants of \$ 0) (Revenue \$ 0)
 Providing new and used clothing and housewares to those in need in our area. The total value of items distributed (estimated) is \$ 70,400. All of these distributions were from in-kind donations, and went to 3930 individuals. We received no revenue from this activity.

 Providing emergency financial assistance to those in need in our area; for such items as payments to avoid utility shut-off, payments to avoid rental eviction, and transportation, medical, or small bills assistance. This help was provided to 604 individuals. All funds for this activity come from donations provided by our Church congregation or other individuals. No revenue was received for this.

Part I Line 2: As we are an organization dedicated to serving the poor, all of our grants and distributions (both monetary and in-kind) are made to individuals who indicate financial need primarily in compliance with income levels suggested by local food banks and similar organizations. Clients must also provide evidence of residence as, per our by-laws, we serve those in our Parish area. Monetary grants (emergency financial assistance) are typically provided only in response to utility shut-off notices, rental eviction notices, and similar situations. Any such monetary grants are paid directly to the utility, landlord, or transportation or medical provider after verification with that provider. We do not give cash or checks to clients, providing a safeguard that funds are used as intended. Records of our financial and food assistance are maintained as paper records at our facility, are kept on forms recommended by our local food banks or other providers, and are updated at each visit by or to a client. Our practices significantly limit the amount of assistance any one client can receive as well as limiting the times they can re-apply for further assistance. Therefore, no individual received aid in excess of \$2000 in total (monetary and in-kind) within a calendar year.

Part III column (b) Our Line 1 (food distribution) recipients number is taken directly from the total household numbers reported and signed for by our clients at distribution, whether at our pantry or delivered; our Line 2 (clothing distribution) recipients are estimated at one-half of our food distribution number based on ongoing observation of those who use these services; our Line 3 (financial assistance) recipients number is based directly upon our individual outlays for those services
