Title IIIC-2, Home Delivered Meal Program. The Central Illinois Agency on Aging provides funding for home delivered meal program for the Central Illinois counties, Peoria, Tazewell, Fulton, Marshall, Stark and Woodford. Meals are provided by organizations by way of grants (contracts). Under the Older American Act, meals are provided to older persons on a donation basis only and must meet the nutritional requirements set forth by the Older Americans Act in the 2006 Amendment. Meals are delivered to the older person's home and are intended for the home-bound. These funds allow for older persons to stay in their homes and communities avoiding institutionalization. Grant (contract) funds received are required to be locally matched. Unused grant (contract) funds are carried over into the following fiscal year.

4b (Code 93.044) (Expenses \$ 733,992 including grants of \$ 237,153) (Revenue \$ 700,791)

Title IIIB, represents resources restricted for strengthening and developing a system of coordinated and comprehensive service programs for senior citizens designed to secure and allow maintenance of maximum independence and dignity for senior citizens capable of self-care in a home environment and to remove individual or social barriers to independence. Specific programs under Title IIIB includes transportation services, assisted transportation services, legal services, outreach, information and assistance to Seniors, options counseling, advocacy for seniors, systems development, systems coordination, and administration. Unused grant funds are carried over into the following fiscal year.

4c (Code 93.045) (Expenses \$ 524,888 including grants of \$ 410,652) (Revenue \$ 536,119)

Title IIIC-1, Congregate Meal Program. The Central Illinois Agency on Aging provides funding for congregate meal programs throughout our services area, which includes the Central Illinois counties of Peoria, Tazewell, Fulton, Marshall, Stark and Woodford. Meals are provided by organizations in each of our service areas and funds are provided to each organization by way of grants. Under the Older American Act, meals are provided to older persons at predetermined locations and are on a donation only basis. All meals must meet the nutritional requirements set forth by the Older Americans Act in the 2006 Amendment. These programs provide mobile older persons socialization and support in addition to balanced nutrition. Grant (contract) funds received are required to be locally matched. Unused grant (contract) funds are carried over into the following fiscal year.
