TODAY, MOST GROUP-BASED CENTERS AND FAMILY CHILD CARE PROVIDERS ARE SMALL BUSINESS OWNERS THAT OFTEN STRUGGLE TO MANAGE THE FINANCIAL ASPECTS OF A PROGRAM WHILE ALSO MAINTAINING QUALITY CARE FOR CHILDREN. SHARED SERVICE NETWORKS (SSN), CURRENTLY OPERATING IN 20 STATES, PROVIDE POOLED ADMINISTRATIVE AND BACK-OFFICE SERVICES AND PURCHASING. AS A RESULT, THEY SAVE OPERATING COSTS, STRENGTHEN THE SYSTEM OF CARE, AND IMPROVE REVENUES BY BRINGING ECONOMIES OF SCALE TO CHILD CARE PROGRAMS. FOR EXAMPLE, A NEW HAMPSHIRE NETWORK, ECE SHARED RESOURCES, HAS SAVED \$6,000 FOR LARGER CENTERS, WHILE SMALL FAMILY PROVIDERS HAVE SAVED OVER \$700 ANNUALLY. WECA'S SHARED SERVICE NETWORK (CALLED WISCONSIN EARLY EDUCATION SHARED SERVICES NETWORK OR WEESSN) WILL GENERATE COST SAVINGS THROUGH CLOUD-BASED ADMINISTRATIVE SERVICES SUCH AS INVOICING, BOOKKEEPING, DATA TRACKING AND REPORTING, WHICH ACCOUNT FOR 15-30% OF THE COST OF CARE, BULK BUYS OF MATERIALS (FOOD, EDUCATIONAL MATERIALS, ETC.), MENTORING IN BUSINESS AND PROGRAM BEST PRACTICE, A SHARED STAFF TRAINING FRAMEWORK, AND, ACCESS TO A POOL OF CHILD CARE PROFESSIONALS SERVING AS ON-CALL "SUBSTITUTES." IN ADDITION, WEESSN PROVIDES FOR SHARED PROFESSIONAL DEVELOPMENT ACTIVITIES THAT INCREASE WORKERS SKILLS AND ELEVATE THE QUALITY OF CARE.
