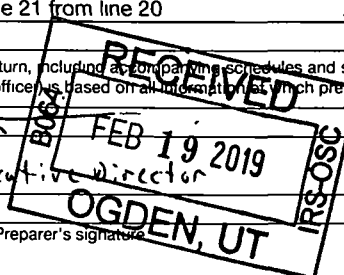

Washington, D.C. In addition, 20 ministers, university professors, social workers, and community leaders led our youth in
educational activities related to justice and root causes of poverty.
