Many provide service to community while they learn through STEAM curricula, robotics programs, or service activities. 4-H has grown to mean much more than agricultural endeavors.

Operational expenses include office expense, accounting, statewide membership organizational capacity support and individual club activity costs that support volunteer families in bringing in resources of dollars, venues, and advertising.

The money set aside for investment of a single large donation was a single, one time movement from revenue into a stock portfolio that will support the organization into the future.
