Adoption Services: During the first three quarters of 2018 which this short year 990 represents we studied 21 families for adoption. During this period we completed 19 adoptions. We provided Adoption case management for 22 children awaiting adoption. We handled 30 inquiries for adoptive services whether via our website, the Michigan Adoption Exchange website, or word of mouth. We also conducted 32 orientation sessions for adults considering adoption, foster care or both.

Pregnancy Counseling: During this period we provided 20 hours of pregnancy counseling to 2 pregnant women. This pregnancy counseling was provided at no charge to the women. We also paid for rent and groceries for a birth mother who could not work during her pregnancy at an expense of \$750.00

Foster Home Certification/Foster Care Services. During the period this short year 990 covers we applied for a foster home certification foster care case management license through the state of Michigan Department of Health and Human Services. We were approved to provide these services at the end of the third quarter and anticipate providing them in our next fiscal year. Expenses noted were for state fee for licensure application and for DBA (Doing Business As) application with the state of Michigan to allow us to operate under the name "Open Door Family Services" which reflects that we will be offering charitable services beyond just adoption.
