Citizens Committee for New York City's mission is to help New Yorkers - especially those in low-income areas - come together and improve the quality of life in their neighborhoods. In 2018, we awarded micro-grants and project assistance to almost 500 grassroots neighborhood projects, mobilizing more than 11,454 residents as volunteers across all five boroughs and investing over \$2.1 million in grants and services to improve quality of life in New York City. Citizens Committee was founded by Senator Jacob Javits and "Newsweek" Editor-in-Chief, Osborn Elliott in 1975 to encourage New Yorkers to volunteer their time to help get the city through the fiscal crisis. Our strength at Citizens Committee is our unparalleled connection to active groups in every corner of the city. We know them and we also know that with just a little support, they can do so much to enrich their communities.
