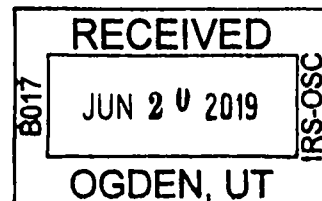

ALSO, HUD DETERMINED THE POLICIES OF DOCUMENT RETENTION. THE PROJECT'S REGULATORY AGREEMENT STIPULATED THAT THE PROJECT WILL NOT MAKE DISTRIBUTION OF ASSETS OR INCOME TO ANY OF ITS OFFICERS OR DIRECTORS. ALL INCOME RECEIVED CONSIST OF RENT PAID BY TENANT & HUD RENTAL ASSISTANCE SUBSIDY. THE PROJECT ALSO RECEIVED INCOME FROM LAUNDRY USED BY RESIDENTS AND INTEREST INCOME FROM RESERVE REQUIRED BY HUD. THE CORPORATION IS EXEMPT FROM TAXATION UNDER SECTION 501 (C) (3) OF I. R. S. CODE. HUD REQUIRED ANNUAL AUDITED FINANCIAL STATEMENTS (FINANCIAL POSITION, STATEMENTS OF ACTIVITIES AND CASH FLOW) FOR THE YEAR THEN ENDED. THE STATEMENT ARE ELECTRONICALLY SUBMITTED TO REAC EACH YEAR.
