The Trust and its affiliates account for uncertain tax positions in accordance with FASB Interpretation No. 48, Accounting for Uncertainty in Income Taxes (included in FASB ASC Subtopic 741-10, Income Taxes - Overall). There is no impact as a result of this pronouncement as the Trust and affiliates have no significant uncertain tax positions. On December 22, 2017, the President signed into law H.R. 1, originally known as the Tax Cuts and Jobs Act. The new law includes several provisions that result in substantial changes to the tax treatment of tax-exempt organizations and their donors. The Trust and affiliates have reviewed these provisions and the potential impact and concluded that the enactment of H.R. 1 will not have a material effect on the operations of the organization.
