Twenty-one parish conferences located in central and southern Alabama provided person-to-person assistance to impoverished members of the community. Conference members visited those in need, offering direct assistance in many forms, including food, utility payments, rent or mortgage assistance, prescriptions, or simply listening with compassion and offering prayers. 16,175 people were helped during 4,571 visits; in-kind services valued at \$4,506 were rendered in 34 instances; and, goods valued at \$270,003 were provided in 3,582 instances. Conference members devoted 33,704 hours of service, logging 43,833 estimated miles.

The District Council supported the conference members who serve the poor with training workshops, retreats and materials, conducting an Ozanam Orientation with 35 members in attendance.
